History of Capital Punishment

Late 1700s - US abolitionist movement begins.

Cesare Beccaria's "On Crimes and Punishment" inspires early abolitionists

Early 1800s

Many states reduce their number of capital crimes and build state penitentiaries.

Early 1900s - "Progressive Period"

A period of US reform (Roosevelt), 1907-1917 - Nine states abolish the death penalty for all crimes or strictly limit it.

1920s - 1940s -American abolition movement loses support

1924 Cyanide Gas introduced, 1930s highest execution rates (average 167 per year)

1958 - Trop v. Dulles

Eighth Amendment's meaning contained an "evolving standard of decency that marked the progress of a maturing society."

1970s - Georgia Cases

Furman v. Georgia (1972) suspends the Death Penalty, later reinstated in 1976 with Gregg v. Georgia under "guided discretion"

1994 - The Violent Crime Control and Law Enforcement Act

President Clinton expands the federal death penalty and later restricts review in federal courts.



Current // Future Policy

States that Banned

Capital punishment is currently authorized in 27 states. CA, OR, and PA have an active moratorium on the practice.

Partisan Divide


Republican-leaning individuals are much more likely than Democrats and Democratic leaners to favor the death penalty for convicted murderers (77% vs. 46%).

Public Support

In phone surveys conducted by Pew Research Center between 1996 and 2020, the share of U.S. adults who favor the death penalty fell from 78% to 52%.

Death sentences, executions have trended downward in U.S. since late 1990s

Number of new death sentences and executions, by year




